

A 5% growth cap will have limited impact on the majority in the sector

Providers already have 5% more EU and home applicants than at June 30th 2019

While the focus is on those who may be close to reaching the cap, this misses the point that many more providers -88 – are down by 5% or more.

What impact might this have on current applicants?

Our analysis shows that, with many assumptions,

fewer than **0.5%** of applicants would be impacted by a cap.














Significant increase since Wave 2



WHAT THIS MEANS FOR PROVIDERS

If you haven't made a decision on start dates then this is needed from applicants imminently. Offer certainty and reassurance where you can.

Be realistic that all options have implications for learners' eventual choices Most applicants still seem hesitant to start concrete preparations – so, do everything you can to encourage this – and give them something to look forward to



May 11th 2020

The 5% cap is not likely to have a significant impact on the sector

Applicants are chiefly concerned with missing a real University experience and learning online

45% are now considering changing their choices

52% want to start uni in Sep even with social distancing

All starting options may precipitate applicants to make a different choice for themselves
